**ACKNOWLEDGMENT OF RISK**

**I HEREBY ACKNOWLEDGE AND AGREE** that the sport of rock climbing and the use of the facilities of the Lake Geneva Christian Center Climbing Wall (hereinafter referred to as the Wall), its climbing wall and other training facilities, has inherent risks. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Wall.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Wall and that the above list in no way limits the extent or reach of this release and covenant not to sue.

**RELEASE/INDEMNIFICATION AND COVENANT NOT TO SUE**

In consideration of my use of the Wall, I, the undersigned user, agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, **HEREBY DO RELEASE** Lake Geneva Christian Center, its officers, agents, sponsors, and employees from any cause of action, claims, or demands, of any nature whatsoever, including but not limited to, a claim of **NEGLIGENCE**, which I, my heirs, representatives, executors, administrators, and assigns may now have, or have in the future against the Wall on account of personal injury, property damage, death or accident of any kind, arising out of or in anyway related to my use of the Wall, whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to the **NEGLIGENCE** of Lake Geneva Christian Center, its officers, agents, sponsors, and employees.

In consideration of my use of the Wall, I, the undersigned user, agree to **IDEMIFY AND HOLD HARMLESS**, Lake Geneva Christian Center, its officers, agents, sponsors, and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatever arising out of or in any way relating to my use of the Wall.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Wall and that I am voluntarily assuming the risks. I understand that I will be solely responsible for any loss or damage, including death, I sustain while using the Lake Geneva Christian Center Climbing Wall and that by this agreement, I am relieving Lake Geneva Christian Center and all other event sponsors of any and all liability for such loss, damage, or death.

I further certify that I am in good health and that I have no physical limitations which would preclude my safe use of the facilities.

**CROSS OUT IF UNDER 18 YEARS OF AGE.** I further certify that I am of lawful age (18 years or older) and otherwise legally competent to sign this agreement, I further understand that the terms of this agreement are legally binding and I certify that I am signing this agreement, after having carefully read it, of my own free will.

**CONTRACT TO FOLLOW SAFETY POLICIES OF CLIMBING WALL**

I, the undersigned user of Lake Geneva Christian Center Climbing Wall, accept full responsibility for my own safety and the safety of other climbers while on the premises of Lake Geneva Christian Center. I agree to abide by, and to help enforce, the following Safety Policies:

1. All climbers must have a signed Release Form on file at the Wall and present a photo ID if requested to gain access to the Wall.
2. Climbers will tie the rope directly into their harness with a Figure 8 retrace knot.
3. Lake Geneva Christian Center reserves the right to deny access to its facilities to any individual permanently or for a specified period of time for breach of contract in following Safety Policies, or for any conduct that is viewed as unsafe or inappropriate.
